# Political approach

---

## □ Decisions about:

- the future of existing residential neighbourhoods;
- the creation of new neighbourhoods (to get an overview of the development of the entire municipality and choose the most advantageous development option in a rational way);
- development of a diverse supply of housing and enhance the development of functionally diverse and socially integrated residential neighbourhood with the aim to reduce such negative trends as stratification of towns' residential areas by the income level of their population.

## □ Strategies and policy papers for support on the basis of decisions:

- existing residential building stock (better quality of living conditions) ;
- prevention of segregation;
- environment restoration (incl.facilitation of area);

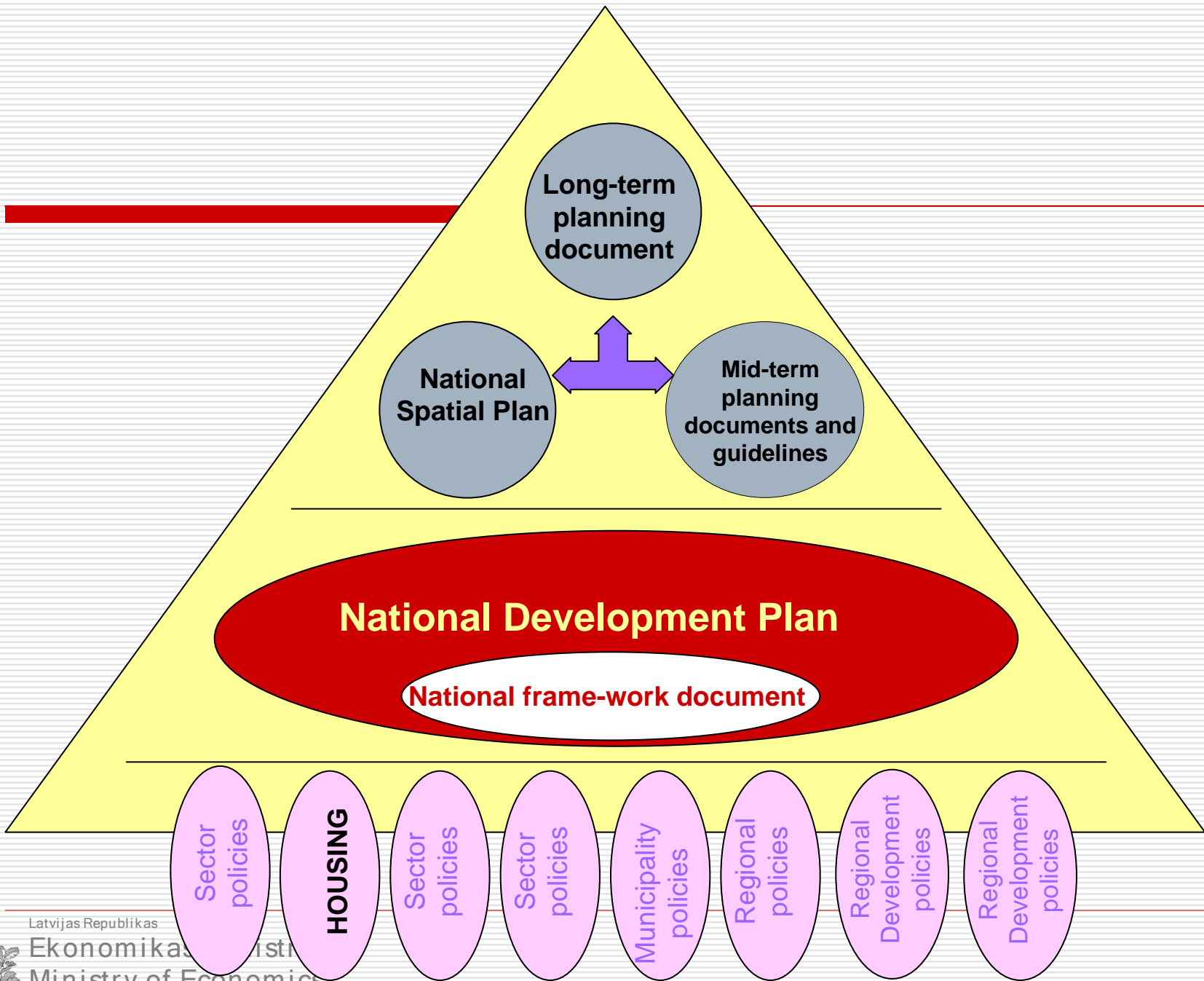

# EU regulation

---

- EU describes the circumstances for using EU fund in the following :  
(expenditure shall be programmed within the framework of an integrated urban development operation or priority axis for areas experiencing or threatened by physical deterioration and social exclusion.)
  
- The areas for housing operations must describe by least three of the criteria. The criteria are *(Commission regulation No 1828/2006 of 8. December 2006)* :
  - a. a high level of poverty and exclusion;
  - b. a high level of long-term unemployment;
  - c. precarious demographic trends;
  - d. a low level of education, significant skills deficiencies and high dropout rates from school;
  - e. a high level of criminality and delinquency;
  - f. a particularly rundown environment;
  - g. a low level of economic activity;
  - h. a high number of immigrants, ethnic an minority groups, or refugees;
  - i. a comparatively low level of housing value;
  - j. a low level of energy performance in buildings.

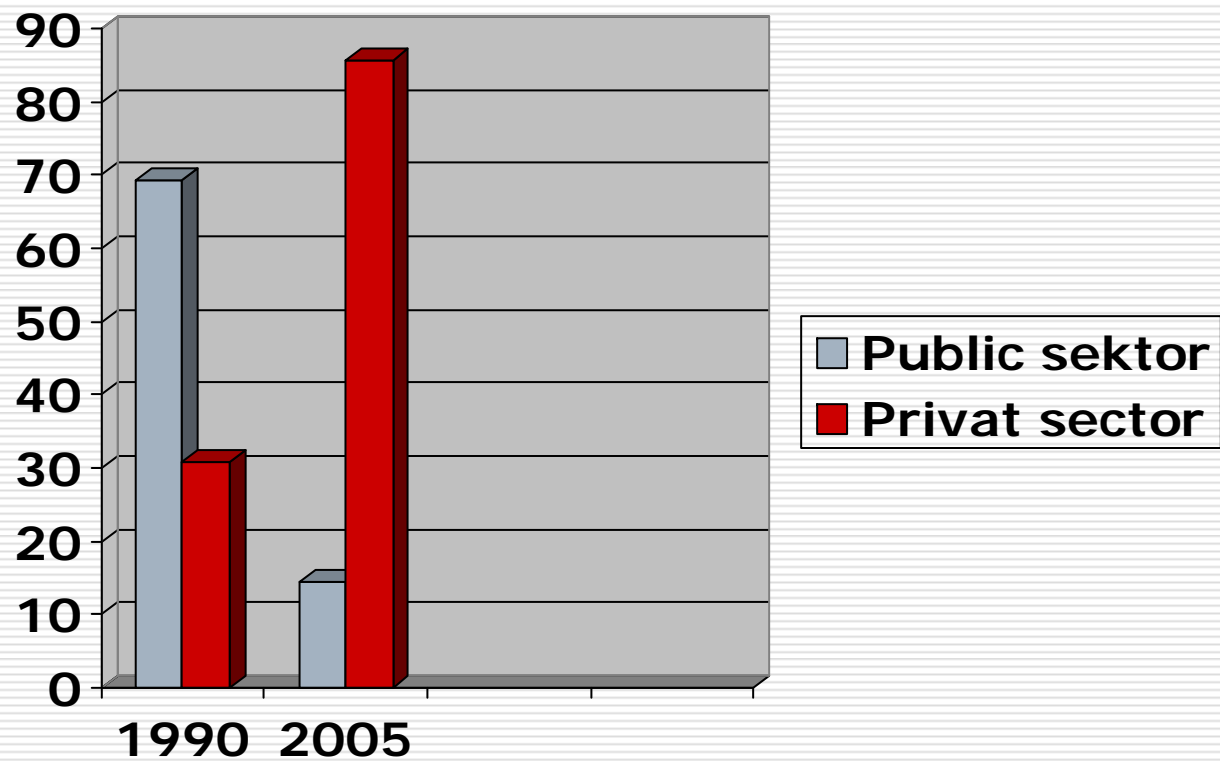

# Planned activities

---

## **State support program for promotion of apartment houses renovation (approved on 15 of May 2007)**

### **Program purposes:**

- To stimulate renovation of privatized apartment houses;
- Promote energy efficiency;
- To create preconditions for further social integration of society (dwelling owners will take decisions on apartment house managing commonly).



---

**Receivers** - dwelling owners association or other authorised person.

**Planned financing:**

Year 2007. – 0.52 milj. LVL (~0.74 million Euro)

Year 2008. – 2.39 milj. LVL (~3.40 million Euro)

Year 2009. – 2.75 milj. LVL (~3.92 million Euro)

Year 2010. – 1.26 milj. LVL (~1.79 million Euro)

- ❑ **Objective** -Implementation of Measures concerning energy efficiency of housing in the rental housing resources in order to ensure sustainability of the resources and effective use of energy resources.
- ❑ **Target Groups** – Dwelling owners association or other authorised person .

  - - technical installations of the building;

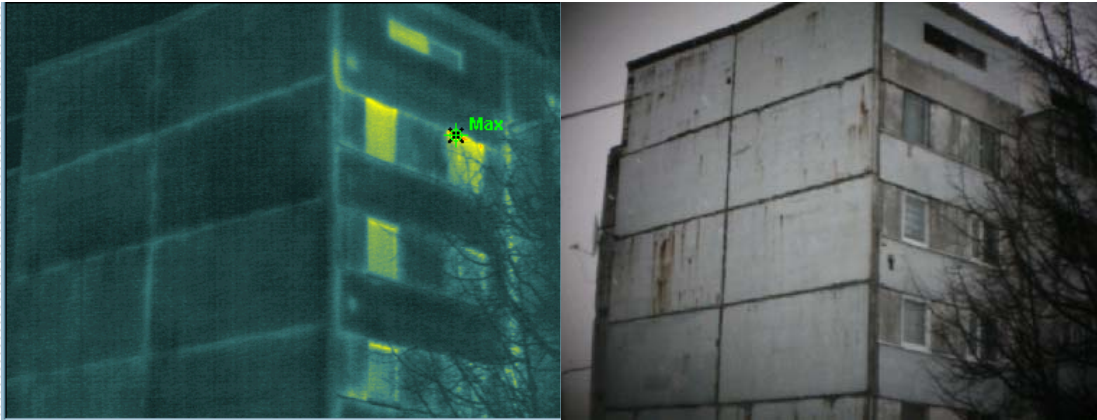
